SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recompleate or abandon a well or to change plans. Within thirty (30) days after recompleation, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

Place 15 sack cement plug over "D" Sand perforations (5768-5774). Pull production casing and place 15 sack cement plug at base of surface casing at 170 feet. Place 10 sack cement plug at top of hole and weld plate on surface casing below plow depth. Heavy mud will be placed between plug.

Well is currently producing 3 B.O.P.D. and is uneconomical to operate.
