It was observed in this inspection that final reclamation is "in process". Access road/Location have been recontoured and revegetation appears to be progressing towards ECMC 80% desirable perennial vegetative standards. There are areas along the central and western end of the Location that may require interseeding to ensure uniform establishment.

Noxious weeds not apparent at time of inspection.

Continue to monitor and manage the Location. Conduct work as necessary to ensure site meets ECMC 1004 requirements.
