INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SANDAU 34-11F flowline removal. Approximately 1819' of flowline was removed. Additionally, soil samples were / will be collected at points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

The flowline was sampled at the separator by Fremont Environmental during decommissioning of the associated facility (REM #25708).

A grab soil sample was / will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples were / will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were / will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were / will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
