This Outcome Notice is to inform you of the status of the violation(s) alleged in the above referenced Warning Letter.

Alleged Violation(s) and Required Corrective Action(s):

34-60-121(1) CRS-b Statutory Violation - Permit Violation

Violation Discovery Date: 01/19/2024

Description of Alleged Violation: According to Form 4 doc# 400898442 approved 2/22/2016, the maximum injected fluid volume was limited to 36,000,000 barrels.

As of Jan 19th 2024, Operator's cumulative form 7 reports of injected volumes totaled 36,063,088 barrels of water.

Required Corrective Action: Answer, due within 14 days of the Operator's receipt of the warning letter, Operator shall provide the following to ECMC:

- Well over the maximum limits is to be shut in.
- Well will be brought into compliance or plugged and abandoned.
