Operator discovered line leaking approximately 1:06 pm and and shut in and contained it at 1:30pm. Standing liquids were removed by vac truck and spill path is being water washed. 3 inch fiberglass line failed

Preliminary soil samples were collected from the spill path on 7/11/23 and from beneath the repaired flowline on 12/20/22. A total of seven (7) grab samples analyzed for Table 915-1 parameters were collected at depths ranging from 0 to 7 feet below ground surface. Results indicate elevated SAR, EC and pH within the impacted area at varying depths.
