INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Existing equipment is being removed and well P&A'ed. No impacts are anticipated, but will be investigated. All removed equipment footprints and surrounding trenches including wellhead, tank battery, flowlines, separator, or other equipment on location will have visual, olfactory, PID inspection and tank battery, wellhead, separator, flowlines will have confirmation by laboratory analysis. Laboratory analysis will consist of TPH, EC, SAR, pH, Boron, BTEX, naphthalene, 1,2,4-trimethylbenzene and 1,3,5-trimethylbenzene. Photos will be taken and attached to a supplemental form 27 of areas under equipment once the equipment has been removed.

We will collect one grab sample or more if needed for the tank battery at locations where the containment liner is penetrated by dumlins or at a seam at a low spot if no flowlines penetrate liner, and at separators, wellhead line trench, dumlins trench and wellhead at the location of most likely high impact under or near the equipment. Laboratory analysis will consist of TPH, EC, SAR, pH, Boron, BTEX, naphthalene, 1,2,4-trimethylbenzene and 1,3,5-trimethylbenzene.
