Laboratory analytical data indicated a historical release occurred at the flowline directional change at the Bernhardt J #31-33D decommissioned wellhead during flowline decommissioning activities. One soil sample (FL-SS-02) exceeded ECMC standards for benzo(a)anthracene at 0.124 mg/kg. A supplemental form 27 has been submitted to REM 32763 detailing the remedial site plan, document number: 403769712.
