Location is within High Priority/Density/Black Bear Habitat areas/Bald Eagle Roost sites. Location is within Rule 411a Surface Water External Buffer & in close proximity to Rule 411b Generalized External Buffer. Location is approximately 50 yards from a creek/drainage that contributes to the Colorado River. While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

- Stormwater - Berm needs maintenance/erosion & transport of sediment off location with a CA date of 05/06/2024
