INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Flowline removal operations were completed at the Freauff 33-4A flowline on October 25, 2023. The Freauff 33-4A wellhead was previously plugged and abandoned. Groundwater was not encountered in the flowline pothole excavation areas. Soil samples were collected from the locations where the flowline direction changes (FL-B03@4' and FL-B19@4') and disconnects from the separator (FL-B01@4') and submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results for FL-B19@4' indicated were within ECMC Table 915-1 or site specific background levels, with the exception of SAR. Therefore, a verification soil sample along with area specific background samples will be collected to determine further assess elevated concentrations. However, assessment activities are on hold due to high priority habitat (HPH) restrictions. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data are presented in Table 1. The soil sample and field screening locations are illustrated on Figure 2. The field notes and a photographic log are provided as Attachment B.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

From October 25, 2023 through December 15, 2023, flowline removal activities were conducted to assess soil at the former flowline location. Soil samples were collected from the locations where the flowline direction changes (FL-B03@4' and FL-B19@4') and disconnects from the separator (FL-B01@4') and submitted for laboratory analysis to determine if a release occurred. The soil samples were submitted for laboratory analysis of BTEX, TPH, naphthalene, TMBs, pH, SAR, EC, and boron using ECMC-approved methods. Assessment activities are on hold due to high priority habitat (HPH) restrictions.

The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.
