INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Decommissioning activities were completed at the Knox 11&14-3 O SA facility on June 12 and 13, 2023. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils at one separator, one meter house, one produced water vessel (PWV), and one aboveground storage tank (AST) was conducted following removal activities, and soil samples (SEP-B01@4', SEP-B02@4', PW-B01@5', PW-E01@2.5', and AST-B01@3") were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results indicated that constituent concentrations in the soil samples were in compliance with ECOM Table 915-1 standards or within site-specific background concentrations. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The facility soil sample and field screening locations are illustrated on Figure 2. Laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On June 12 and 13, 2023, soil samples were collected from the base (PW-B01@5') and east sidewall (PW-E01@2.5') of the PWV excavation, the separator excavations (SEP-B04'@', SEP-B02@4'), and beneath the AST (AST-B01@3"). The soil samples were submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, TPH GRO (C6-C10), DRO (C10-C28), and ORO (C28-C40), pH, EC, SAR, and boron using ECOM approved methods. Analytical results indicated that constituent concentrations in the soil samples were in compliance with ECOM Table 915-1 standards or within site-specific background concentrations. Soil analytical results are presented in Tables 2 and 3. The laboratory analytical reports are provided as Attachment A.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On June 12 and 13, 2023, visual inspections and field screening of soils was conducted at three sidewalls of the PWV excavation, one former meter house, and one former AST location. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the ECOM Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and photographic log are provided as Attachment B.

Background soil samples PW-BG01@3' - PW-BG04@3' and PW-BG01@6' - PW-BG04@6' were collected from native material near the tank battery. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters using standard methods appropriate for detecting target analytes in Table 915-1. Analytical results for the background soil samples are presented in Tables 3.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base and south sidewall of the PWV excavation (PW-B01@5', PW-E01@2.5'), separator excavations (SEP-B01@4', SEP-B02@4'), and from beneath the former AST (AST-B01@3") were in compliance with ECMC Table 915-1 standards or within site-specific background concentrations. The excavation areas will be backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base and south sidewall of the PWV excavation (PW-B01@5', PW-E01@2.5'), separator excavations (SEP-B01@4', SEP-B02@4'), and from beneath the former AST (AST-B01@3") were in compliance with ECMC Table 915-1 standards or within site-specific background concentrations. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.

	<p>Based on the information presented, it appears the elevated pH sample from the wellhead area appears to be de minimis in quantity or within the range of background pH and there is not indication of a spill or release; therefore, elevated pH may not be associated with E&P activities. It appears that no further remedial action is necessary at this time and the ECMC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding ECMC standards or background levels or if groundwater is found to be impacted, then further investigation and/or remediation activities may be required.</p> <p>The surface area disturbed by the remediation activity shall be reclaimed in accordance with the 1000 Series Reclamation Rules.
