Due to tight spacing on site, excavated soil needed to be stockpiled prior to being loaded on trucks rather than being loaded directly into the trucks by the excavator. No stockpiled soil remained overnight. On the day of the inspection, 4/17/2024, 46 loads of soil were transported to

the Buffalo Ridge Landfill.
