Inspection required Operator to comply with 1004 Rules and conduct additional reclamation.</p> <p>Operator submitted FIRR 403411185 stating additional reclamation efforts were performed November 2022 and additional time was necessary.</p> <p>Location is within the beginning of the 2nd growing season since additional work, however, It was observed in this inspection that areas on the north end of the Location remain predominantly Undesirable Weedy Plant Species.</p> <p>An additional assessment will be conducted towards the end of the 2024 growing season to determine compliance with 1004 Rules.</p>	trujilloam	05/02/2024
