This well does not fit the definition of Temporarily Abandoned as defined in ECMC 100 Series rules. Instead, this well is Shut-in due to the ECMC Director's 901.a Order dated April 12, 2021. It is capable of production without a downhole intervention, removal of a plug, or addition of equipment. KPK disagrees with the requirement to conduct an MIT on this well and has previously requested a partial withdrawal of the 901.a Order and the ability to unload well liquids thereby resetting the clock for MIT testing. In the alternative, KPK proposed continuously monitor Bradenhead pressures to satisfy the MIT requirement; this practice was previously approved and implemented by another operator. KPK renews it request to unload the Shut-in 901.a Order wells.
