Soil sample results will be submitted when received. Sampling activities occurred 4/13/2023, results indicate no hydrocarbon impacts at the WH. Elevated pH levels remain at SP1, SP3, and SP4. Samples will be collected along the FL at areas most likely to have been impacted during the operational life of the FL. Following flowline investigation, a reclamation plan will be submitted (Note: site is in cropland).
