INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the VOLKENS 31-22 wellhead cut and cap and flowline abandonment. The wellhead will be cut and capped per ECMC rules. Approximately 558' of flowline will be abandoned-in-place. This flowline lies in a common trench with at least one other line. So as to not disturb the other line(s) sharing the common trench, soil samples will only be taken at the wellhead and at the endpoint of the flowline. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation and start/end points of the flowline. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead area will occur during abandonment activities. The ECMC Wellhead Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Wellhead decommissioning activities and confirmation soil sampling at the Liggett 18-06 wellhead occurred on April 19, 2024. Two confirmation soil samples were collected from the wellhead excavation (WH01@6) from approximately 6 feet below ground surface (ft-bg) and from adjacent to the wellhead flowline riser (FLR01@4) from approximately 4 ft-bgs. One confirmation soil sample (WH01@6) was collected from approximately 6 ft-bgs from the wellhead floor and reported Ethyl-Benzene (4.46 mg/kg), Xylenes (102 mg/kg), 1,2,4-Trimethyl-Benzene (39.2 mg/kg), 1,3,5-Trimethyl-Benzene (9.22 mg/kg), Naphthalene (1.19 mg/kg), TPH, (3,547 mg/kg), TPH GRO (1540 mg/kg), TPH DRO (1510 mg/kg), 1-Methyl Naphthalene (1.99 mg/kg) and 2-Methyl-Naphthalene (5.44 mg/kg) above the Table 915-1 ECMC GWSSLs and was reported as a historic release in Form 19 document number 403781408. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 33147.

This Supplemental Form 27 was prepared for the historic release that was discovered at the Volkens 31-22 wellhead and in connection with the initial Form 19 submitted under Document 403781408.

Excavation activities are not scheduled at this time. Following landowner negotiations, supplemental source mass removal activities will be initiated via mechanical excavation.

Flowline removal/abandonment activities will be summarized in a separate supplemental form 27 submittal.
