INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form is being submitted to comply with COGCC Rules 911.a.(4), 913.a., 913.b.(1), 913.b.(2), and 913.c.(9). The form serves as the initial notification to abandon multiple pipelines and associated risers that convey production fluids offsite from the O36A-596 (ECMC Location ID 335583) and the O36B-596 (ECMC Location ID 335658).

On 12/20/2023 and 12/26/2023, 15 soil samples were collected from existing excavations (and resulting stockpiles) associated with the abandonment of pipeline risers/infrastructure. All samples were submitted for laboratory analysis of all analytes listed in ECMC Table 915-1. Laboratory analytical results indicate that all samples exhibited EC, SAR, pH, and/or arsenic exceedances of ECMC Table 915-1 Residential Soil Standard Cleanup Levels. Please see the attached documents titled "O36 Pipeline Decommissioning Riser Abandonment Soil Assessment Field Notes - 12-20-2023" and "O36 Pipeline Decommissioning Riser Abandonment Soil Assessment Field Notes - 12-26-2023" which detail the sampling events and sample locations. Also attached to this form is an analytical table summarizing the analytical results as well as the official laboratory analytical reports.
