Comment This location does not comply with Rule 1003. During this inspection, it was observed that interim areas do not appear to be progressing towards reclamation/vegetative standards with evidence of undesirable vegetation (e.g. kochia) and Colorado List C Noxious weed (field bindweed) observed on the production areas. Corrective Action Comply with Rule 1003. Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards.
