The Jurisdictional Agency determination was based on information contained in or added to the Application. Review by the professional staff of the Colorado Commission indicates that this well is an (~~New~~) (Old) well. The well produces from the "J" Sand reservoir(s); This well qualified as a stripper well under Filing No. 83-460 . The well produced non-associated natural gas at a rate exceeding 60 Mcf per producing day for the "90 day" period ending August 31, 1984 . Production from the well was 2383 Mcf during the "90 day" period. A petition for "Temporary Pressure Build-up" was subsequently filed showing that the well was temporarily shut-in 87 days.

This conclusion was originated by examination of the contents of the petition.

Which show this well increased daily average production due to temporary pressure build-up when shut in due to pipeline demand and therefore qualifies as a "Temporary Pressure Build-up stripper well under FERC Rule 271.804(e).

Therefore meets the qualifications of a (108) well as defined in the N.G.P.A.
