A site investigation was conducted pursuant to COGCC rule 911 at the State Pronghorn X-29 Pad (438608) oil and gas location pertaining to the removal and replacement of (3) separators that are within lined containment. All other wells and equipment will remain active. See site map exhibit for details.

The separators are within lined containment. The risers associated with the separators and flowlines will not be removed and will be marked for future use. The integrity of the liner was confirmed to be in good condition during removal of the separators, therefore the ground surface had no impacts and soil samples were not collected at this time.
