For comparison to background soil conditions, up to four soil samples may be collected from nearby, undisturbed native areas and submitted for analysis of Electrical Conductivity (EC), Sodium Adsorption Ratio (SAR), pH, Boron, and metal constituents listed in ECOM Table 915-1.
