A site investigation was conducted pursuant to ECMC Rule 911 at the ADAM RED WASTE MGMT T3N-R64W-S26 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per COGCC Table 915-1. Additionally, groundwater will be analyzed for inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO3), per the COA associated with ECMC document number 403416564.

Visual inspection at the tank battery area occurred during abandonment activities. The ECMC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process. A photolog is included on this Form 27.

One background soil boring (BKG01) was collected from native soil adjacent to the former Waste Management D26-25 Tank Battery location. Samples were collected at 3 ft. and 4 ft. below ground surface and submitted for analysis of metals in soil per ECMC Table 915-1 and pH.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed at AST02@0.5' during decommissioning. A proposed SSI map is attached to this Form 27. Based on the contaminants of concern identified in waste characterization sample AST02@0.5', Noble proposes to limit future soil sampling to arsenic and pH. Concurrently with the SSI, additional background samples will be collected to determine if arsenic and pH should be considered contaminants of concern. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.
