Comment: Desert Eagle Operating (DEO) endeavors to operate in a manner that protects public health, safety, welfare, the environment and wildlife resources by complying with all the rules and regulations of the ECMC. In response to the this Field Inspection form, DEO provides the following: The chemical fuel containers and secondary containment units were no longer required and have been removed from the location. A game fence is installed around the compressor for wildlife protection. Rule 902.b. Photos attached. Tree debris has been removed and bermed areas along the road have been stabilized Rule 606. Photos attached. Stained soils around the compressor engine have been cleaned up. Oily fluids in the engine skid mount and inside secondary containment was removed. Third party personnel have been instructed on good housekeeping practices and Desert Eagle Operating (DEO) personnel have reviewed self-inspection processes. Rule 1002.f.(2) B.D. Photos attached. Areas of the location were prepared and seeded; however, sparse germination has been attributed to several factors: lack of rain, lack of topsoil/soil amendments, and remaining areas of heavily compacted soils. DEO is preparing to address these issues with additional soil ripping, applying additional topsoil, and reseeding. DEO continues to evaluate the identified drill cuttings waste and clean up at the north side of the location and is proceeding with drill cuttings clean up under Form 27. Updated FIRRs will be submitted upon completion.
