Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

OPERATOR COMMENT

The Operator proposes to attribute elevated concentrations of metals and pH to native soil conditions based on concentrations in the background samples being greater than concentrations of the same constituents observed in the confirmation sample. Since lab analysis and AVO observations show no evidence to support a the occurrence of a spill or release at the location since all organic and inorganic constituents (beside pH) were in compliance with the Table 915-1 concentration standards. Further VOC and SVOC concentrations were all in compliance and/or "non detect". Therefore outstanding concentrations are unlikely to be related to oil and gas production activities.
