 Perforate and cut 4 1/2" production casing at free point.  
 Pull and lay down 4 1/2" production casing.  
 Set 200' of cement half-in and half-out of surface pipe (726').  
 Set 5 sacks of cement at top of surface pipe.  
 Cut off surface pipe off 4' below ground and weld on steel cap.  
 Remove deadmen, back fill pits, cleanup and level location.
