A site assessment will be conducted pursuant to ECMC rule 911 at the SE CAMPO UNIT 402W produced water injection wellhead cut & cap and its associated offsite injection line to be abandoned in place.

A grab soil sample will be collected from the floor of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead cut & cap excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead excavation. If impacts are not apparent from visual, olfactory, and PID screening, the floor soil sample will be analyzed by a certified laboratory for full ECMC Table 915-1. If there are any apparent potential impacts, grab soil samples from those locations will be collected and analyzed for full ECMC Table 915-1. Grab background soil samples will be collected from outside of the location perimeter at multiple depths and analyzed for ECMC Table 915-1 Soil Suitability for Reclamation and Metals. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the injection line will occur during assessment activities. Field staff will use a PID to field screen a minimum of every 250' adjacent to the injection line to determine if laboratory analysis is required. Grab soil samples will be collected for lab analysis at change(s) in direction of the injection line as well as the end of the injection line at the isolation valve. If impacts are not apparent from visual, olfactory, and PID screening, the vertex and terminus injection line soil samples will be analyzed by a certified laboratory for full ECMC Table 915-1. If there are any apparent potential impacts, grab soil samples from those locations will be collected and analyzed for full ECMC Table 915-1. The ECMC Wellhead and Flowline Closure Checklists will be completed during the assessment. A photolog will be submitted on the Subsequent Form 27.

Due to this location being within Lesser Prairie Chicken High Priority Habitat (active March 1 - July 15), planned assessment activities are currently on hold. Murfin's environmental consultant is also waiting for the SE Campo Unit 401 (05-009-06371) and SE Campo Unit 101 (05-009-06440) wells to be plugged so the initial assessments for all 3 can be completed in one trip from the Denver area. This form is being submitted to satisfy the 90-day submission requirement.

Water well documents available on Colorado Division of Water Resources online database for water well receipt number 9072608 approximately 1,860' N from the wellhead state a static groundwater level of 187' bgs. Per ECMC Rule 915.a., operators will adhere to the concentrations for soil cleanup in Table 915-1. Operators will use Residential Soil Screening Level Concentrations as cleanup levels.
