On 6/3/24 at approximately 11:00, a Caerus contractor was hydro-excavating the dumpline at the Puckett 44C-25 in preparation for facility closure work. Historic contamination exceeding 10 cubic yards was encountered near the dumpline riser at the tank battery. The line had already been blown down and the facility shut in.
