INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the VOLKENS 31-22 wellhead cut and cap and flowline. The wellhead was cut and capped per ECMC rules. Approximately 558' of flowline was removed. This flowline lies in a common trench with at least one other line. Soil samples were taken along the flowline at each end point, any points of material change and/or hammer unions, and/or directional changes.

A grab confirmation soil sample was collected from the base of the cut/cap excavation. Two (2) grab confirmation soil samples were collected from the flowline riser/wellhead (Pt. A). Two (2) grab confirmation soil samples were collected from flowline change of directions. One (1) grab confirmation soil sample was collected from a bellhole with suspected impacts. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Two (2) background samples were collected off-pad from similar lithographic soil for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. Residual pH and lead appear to warrant additional sampling/remedial confirmation prior to NFAR. Additional backgrounds (5+) will be collected from soil of native/similar lithographic material to further compare residual pH and lead during remediation activities.

Basis for change in implementation schedule:

Based on the discovery of historic hydrocarbon impacts during the wellhead assessment, and subsequent flowline assessment, source mass removal activities will be initiated following landowner negotiations. The implementation schedule has been updated to reflect these changes and likelihood based on current ag operations adjacent to the site.

OPERATOR COMMENT

The wellhead and flowline decommissioning assessment was completed at the Volkens 31-22 location in accordance with approved initial Form 27 Doc. #403600071, included under related forms. Current form includes a data summary to document the historical releases identified at the site.

Residual petroleum hydrocarbon impacts observed will be removed through excavation. The Spill Point/Release ID to address the impacts identified along the flowline has not yet been created and will be provided on a Supp. Form 27 with a more detailed remediation and sampling plan.
