No work has been completed on this project since the Initial Form 27 was submitted. Due to a schedule change in early 2023, the well associated with this project was not plugged and abandoned (P&A'd) in 2023. It is scheduled to be P&A'd in late 2024. Another Form 27 will not be submitted until assessment work is conducted following the abandonment of the wellhead and associated infrastructure.
