INITIAL ACTION SUMMARY

Pursuant to ECOM Rule 911 a site investigation will be conducted pertaining to the Wess 3 wellhead cut and cap. The wellhead will be cut and capped per ECOM rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECOM Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECOM laboratory analysis methods.
