## **INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WATSON E28-17 wellhead cut and cap and flowline removal. Approximately 220' of flowline will be removed. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

## **PROPOSED SAMPLING PLAN**

### **Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

### **Proposed Groundwater Sampling**

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

No impacted soils were discovered during wellhead cut and cap activities. Based on site investigation activities and laboratory analytical results of confirmation soil samples collected from the wellhead excavation floor, and wellhead flowline riser, removal of soil is not needed. The material excavated during the cut and cap operations was used as backfill for the excavations.

Site investigation dates have been updated based on the dates most recent field activities were completed.

## OPERATOR COMMENT

Facility closure activities and confirmation soil sampling were conducted at the Watson E28-17 wellhead on May 7, 2024. Four discrete soil samples were collected from the sidewalls of the wellhead excavation in each cardinal direction from the wellhead and field screened using a photo-ionization detector (PID) calibrated with 100 parts per million (ppm) isobutylene gas. All soil samples screened with a PID at the wellhead resulted in readings equal to 0.0 ppm.

A total of 2 facility closure confirmation soil samples were submitted for analysis. Soil Samples were collected from the floor of the wellhead excavation (WH01@6), and from beneath the flowline riser adjacent to the wellhead (FLR01@4). All soil samples were submitted to Origins Laboratory, Inc. in Denver, Colorado for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, gasoline range organics (GRO) [C6-C10] by EPA Method 8260D, diesel range organics (DRO) [C10-C28] and residual range organics (ORO) [C28-C40] by EPA Method 8015D, polycyclic aromatic hydrocarbons (PAHs) (Table 915-1 list) and naphthalene by EPA Method 8270E, Total Metals by EPA Method 6020B, Hexavalent Chromium by Total Metals by 7196A Method, electrical conductivity (EC) by Mod. Method 9050A, sodium adsorption ratio (SAR) by 20B Saturated Paste Method, and pH by 9045D Method, and boron by DTPA Sorbitol Method.

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels except for pH in soil samples WH01@6 (8.42) and FLR01@4 (8.59), SAR in soil sample WH01@6 (6.29), arsenic in soil samples WH01@6 (3.30 mg/kg) and FLR01@4 (4.88 mg/kg), barium in soil samples WH01@6 (191 mg/kg) and FLR01@4 (243 mg/kg), and selenium in soil sample FLR01@4 (0.270 mg/kg). All organics were reported as below the laboratory method detection limits. Groundwater was not encountered during wellhead cut and cap activities.

Noble is currently in the process of evaluating residual pH, SAR, arsenic, barium, and selenium concentrations at the wellhead. A detailed work plan will be proposed in a subsequent quarterly supplemental Form 27 submission. Flowline decommissioning activities will be summarized in a separate supplemental form 27 submittal.

Sample location information is provided in Table 1. Soil sample and field screening locations are presented on Figure 2, and analytical results are summarized in Table 2, Table 3, Table 4, and Table 5.
