## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Decommissioning activities were completed at the Moser H 28-29 Facility on February 2, 2024. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils at one separator, one meter house, two produced water vessels (PWV), one emission control device (ECD), and one aboveground storage tank (AST) was conducted following removal activities, and soil samples (SEP-B01@3', SEP-B02@3', PW-B01@7', PW-B02@7', PW-N01@3', PW-N02@3', and AST-B01@3") were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results indicated that constituent concentrations in the soil samples were in compliance with ECMC Table 915-1 standards and/or within site-specific background limits. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The facility soil sample and field screening locations are illustrated on Figure 2. Laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

On February 2, 2024, soil samples were collected from the bases (PW-B01@7', PW-B02@7') and sidewalls (PW-N01@3', PW-N02@3') of the PWV excavations, the separator excavation (SEP-B01@3', SEP-B02@3'), and beneath the AST (AST-B01@3"). The soil samples were submitted for laboratory analysis of the full ECMC Table 915-1 analytical suite. Analytical results indicated that constituent concentrations in the soil samples were in compliance with ECMC Table 915-1 standards and/or within site specific background limits. Soil analytical results are presented in Tables 2-5. The laboratory analytical reports are provided as Attachment A.

## Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan ( summary ):

On February 2, 2024, visual inspections and field screening of soils was conducted at six sidewalls of the PWV excavations, one ECD, one former meter house, and one former AST location. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2-5. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and photographic log are provided as Attachment B.

Laboratory results indicate that constituent concentrations in the soil samples collected from the separator (SEP-B01@3', SEP-B02@3'), bases and north sidewalls of the produced water vessel excavations (PW-B01@7', PW-B02@7', PW-N01@3', PW-N02@3'), and aboveground storage tank (AST-B01@3") were in compliance with ECMC Table 915-1 standards and/or within site-specific background concentrations; therefore, no soils were removed during decommissioning activities. The excavation area will be backfilled and contoured to match pre-existing conditions.

Laboratory results indicate that constituent concentrations in the soil samples collected from the separator (SEP-B01@3', SEP-B02@3'), bases and north sidewalls of the produced water vessel excavations (PW-B01@7', PW-B02@7', PW-N01@3', PW-N02@3'), and aboveground storage tank (AST-B01@3") were in compliance with ECMC Table 915-1 standards and/or within site-specific background concentrations. Groundwater was not encountered during decommissioning activities. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this site.
