On 6/5/2024 at approximately 15:00, a Caerus LDAR Technician was inspecting the P27 595 location and noted gas coming to surface above the flowlines. Pressure testing was conducted and leak was confirmed on the 1D-34 flowline near the wellhead. The flowline was isolated and blown down. Volume released is currently unknown but will be estimated through SCADA trending and hole size at the POR once uncovered.
