Comment:

The well location (Location ID 329443 with API 123-17360) meets final reclamation regulations and standards. Unable to find evidence of oil and gas activities and/or disturbances. Well location and access road vegetation appear reflective of reference pasture areas. The tank battery facility remains active for another nearby well AP#123-26150 and will be associated with that well for final reclamation purposes.

However, at the entrance to the access road a culvert remains where it appears surface owner ditches for the pasture.

Corrective Action:

Remove the culvert and complete final reclamation at the beginning of the access road to comply with Rule 1004.
