## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared in accordance with ECMC Rule 911.a to provide prior notice of closure of the Kugel 12-18, V18-3-4-5 production facility, the plugging and abandonment of the Kugel 12-18 wellhead, and the removal of the associated flowline. The flowline will be permanently removed. The off-location flowline system pre-removal notice was submitted under Form 44 Document No. 403733333. In accordance with ECMC Rule 911.a., soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with ECMC Table 915-1. Visual inspection and field screening of soils will be conducted following decommissioning of the associated infrastructure and soils around the wellhead and associated flowline will be conducted during sampling activities. Soil vapor screening will also be performed around the wellhead. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1. The Form 44 is attached.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Following decommissioning activities, soil will be field screened at the facility infrastructure, wellhead, wellhead & separator risers, & associated flowline. Samples will be collected if indications of impacts to soil or groundwater are present. If impacted soils are encountered, a waste characterization soil sample will be collected from the area exhibiting the highest degree of impact based on visual, olfactory, &/or field screening observations. In the absence of apparent impacts, a soil sample will be collected from the root zone (0-3 feet bgs), the base of the excavation adjacent to the wellhead, adjacent to the wellhead and separator risers, & the areas most likely to have been impacted during the operational life of the flowline. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECMC Table 915-1. Proposed soil sample and screening locations are provided on Figures 2, 3, & 4.

### Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

Following cut and cap operations, a soil gas survey will be conducted utilizing a maximum of five (5) soil vapor points located adjacent to the former wellhead location. The proposed soil vapor point locations are illustrated on Figure 2.
