### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the PROSPECT CO26- 09I4 wellhead cut and cap and flowline removal. Approximately 1190' of flowline will be removed. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Grab confirmation soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. A grab confirmation soil sample will be collected at the wellhead excavation in base of the excavation or the area showing the highest degree of impact during abandonment activities.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. Two background samples were collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the Prospect CO 26-914 flowline location and analyzed for ECMC Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Both background samples exceed the Table 915-1 standards for arsenic. Five background sample locations are proposed of Figure 3 of the attached to provided

Impacted soil will be removed from the release area at the Prospect CO 26-0914 flowline location by excavation. The impacted soil will be disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests will be available upon request.

**REMEDIAL SUMMARY**

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Before excavation of impacted soil, soil borings will be installed to delineate the vertical and lateral extent of soil impacts at and adjacent to the impacted Prospect CO 26-0914 flowline 9FL06@5.0' sample location. Confirmation soil samples will be collected and analyzed for the full Table 915 suite. If groundwater is encountered, the soil boring(s) will be improved with temporary PVC monitoring wells and sampled for Table 915 constituents in groundwater.

A proposed site investigation extent and additional background sample locations are displayed on Figure 3 of the attached. A minimum of five soil boring (one in the perceived source [9FL06@5.0'] and one in each cardinal directions) will be advanced within the proposed site investigation area.

If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site.

Since inorganics achieved the soil suitability for reclamation standards in all samples, including the impacted samples, and metals concentrations in the confirmation samples were less than the highest background concentration the operator is requesting an amended sampling analysis plan which includes the analysis of VOCs, SVOCs only for all further remedial actions related to this project.
