During this inspection the following possible compliance issues were observed: 1. It appears the wellhead fencing is in disrepair. Comply with Rule 603.h. (Corrective Action Date: July 8, 2024) See attached photo #2. 2. It appears to be weeds on/inside tank battery berm and surrounding other equipment (ECD, Sep., gas meter) Comply with Rule 606.
