INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Vogl 5-8A wellhead on June 21, 2023. Groundwater was not encountered in the cut and cap excavation area. Visual inspection and field screening of soils around the well and associated pumping equipment was conducted following cut and cap operations, and a soil sample (WH-B01 @6') was collected from the base of the cut and cap excavation area, as described in a previous Form 27-Supplemental update (Document No. 403533077). Removal of the flowline associated with this wellhead was conducted on June 21, 2023 through March 12, 2024. Soil samples were collected from the locations where the flowline risers were disconnected at the wellhead (FL-B01@4') and separator (FL-B02@4'), and where the flowline changed direction (FL-B03@4', FL-B16@4', FL-B26@4', and FL-B30@4'), and were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results indicated that soil impacts were present at samples WH-B01@6', FL-B01@4', and FL-B02@4' due to the 1,2,4- and 1,3,5-TMB, TPH, PAHs, Ba, Pb, and/or pH results above ECMC standards and/or site-specific background levels (x 1.25 for metals). As such, two Form 19-Initial/Supplemental Spill/Release Reports (Document Nos. 403442749 and 403442990) were submitted on June 23 and 27, 2023, respectively, and the ECMC issued Spill/Release Point IDs 484650 and 484670, respectively. The remaining analytical results for the soil samples collected during wellhead cut and cap and flowline removal activities were in compliance with Table 915-1 standards and/or within site-specific background levels (x 1.25 for metals). Soil sample location and field screening data are presented in Table 1. Soil and analytical results are summarized in Tables 2 through 5. The soil sample and field screening locations are illustrated on Figures 1 through 3.

On December 12, 2023, excavation activities were initiated to address remaining soil impacts at the former wellhead/flowline riser location. Soil samples have been collected from the sidewalls and base of the wellhead/flowline riser excavation area, at depths of approximately 6 and 8 feet below ground surface (bgs), respectively. Based on the waste characterization results for samples WH-B01@6', FL-B01@4', and FL-B02@4', and the ECMC-approved analyte list (Document No. 403533077), future confirmation soil samples from the wellhead/flowline riser excavation area will continue to be submitted for laboratory analysis of BTEX, TPH, TMB, PAHs, select Table 915-1 metals (As, Ba, Cd, Cu, Pb, Se), and pH. Excavation and/or site assessment activities to address remaining soil impacts at the former wellhead/flowline riser location are currently ongoing. Excavation activities to address remaining soil impacts at the former separator flowline riser location have not yet been initiated.

Groundwater has not been encountered during wellhead cut and cap, flowline removal, or subsequent over-excavation activities completed to-date. If groundwater is encountered during ongoing or pending excavation activities at the former wellhead and/or flowline riser locations, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4- and 1,3,5-trimethylbenzene (TMB), using standard methods appropriate for detecting the target analytes in Table 915-1.

On June 21, 2023 through March 12, 2024, soil screening was conducted at 4 sidewall locations within the cut and cap excavation area, 4 locations at the ground surface adjacent to the excavation, and 25 flowline removal pothole locations. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations, and no soil samples were submitted for laboratory analysis from these areas in accordance with ECMC Operator Guidance. On July 5, 2023, a soil gas survey was conducted at 5 soil vapor points (SVP01 - SVP05) installed adjacent to the former wellhead location following cut and cap operations, as described in a previous Form 27-Supplemental update (Document No. 403533077). The laboratory analytical reports for the soil samples collected since the previous Form 27-Supp was submitted are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Four (4) background soil samples have been collected from undisturbed native material adjacent to the wellhead cut and cap excavation area, at comparable depths and soil composition to the confirmation soil samples. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters and Table 915-1 metals using standard ECMC-approved methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Tables 4 and 5. Additional background samples may be collected, for comparison to the remaining inorganic constituent concentrations in the wellhead/flowline riser excavation area.

On December 12, 2023, approximately 30 cubic yards of impacted material were removed from the wellhead/flowline riser excavation area and transported to the Kerr-McGee Land Treatment Facility in Weld County, Colorado for recycling; approximately 10 cubic yards of impacted material were removed from the wellhead/flowline riser excavation area and transported to the Buffalo Ridge Landfill in Keenesburg, Colorado for disposal. Excavation and/or site assessment activities to address remaining soil impacts at the former wellhead/flowline riser location are ongoing, and will be summarized in a forthcoming Form 27-Supplemental update. Excavation activities to address remaining soil impacts at the former separator flowline riser location have not yet been initiated, and will be summarized in a forthcoming Form 27-Supplemental update.

Excavation activities to address remaining soil impacts at the former separator flowline riser location have not yet been initiated, and will be summarized in a forthcoming Form 27-Supplemental update. Future confirmation soil samples will continue to be submitted for laboratory analysis of BTEX, TPH, TMB, PAHs, select Table 915-1 metals (As, Ba, Cd, Cu, Pb, Se), and pH, based on the waste characterization results for samples WH-B01@6', FL-B01@4', and FL-B02@4', and the ECMC-approved analyte list (Document No. 403533077). Based on the analytical and soil screening data presented herein, assessment is complete at the remaining portion of the Vogl 5-8A flowline, and no further assessment activities are required in this area. Estimated time to attain NFA is TBD based on the extent of impacted soil remaining.
