INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the NIX 01 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 586' of flowline was removed.

Three (3) grab soil samples were collected at the wellhead excavation (1), and flowline terminuses at the wellhead (1) and separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
