INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the FRICO 6-14 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Approximately 736' of flowline was abandoned in place.

The Form 44 Document Number will be provided on a supplemental Form 27. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is to be removed at a later date. A site investigation will be scheduled to assess the flowline directional changes

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Two (2) grab soil samples were collected at the wellhead excavation (1) and flowline terminus at the separator (1). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead.

Soil samples will be collected along the flowline path at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, where applicable.

Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were/will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1.

Visual inspection of the flowline area will occur during abandonment activities. The ECMC Flowline Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

The wellhead and initials flowline decommissioning assessments were completed at the FRICO 6-14 location in accordance with approved initial Form 27 Doc. # 403518817, included under related forms.

All organic concentrations are in compliance with ECMC Table 915-1. Elevated arsenic, barium, selenium, Cr VI, and pH were identified at the site. Residual pH will be delineated. Additional backgrounds (5+) will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further compare residual arsenic, barium, selenium, Cr VI, and pH, as needed. Remediation will be discussed in a supplemental Form 27 as applicable.

A site investigation will be scheduled to assess the flowline directional changes, with samples collected for full ECMC Table 915-1 analysis.

The final decommissioning report with analytical lab reports will be provided on a supplemental Form 27.
