How was extent determined?			
Following cut and cap operations at the Dry Creek 11, 23-35 wellhead locations on June 26, 2024, soil samples were collected from the bases and select sidewalls of the excavation areas. The soil samples were submitted for laboratory analysis of the full ECMC Table 915 -1 analytical suite, using standard methods appropriate for detecting the target analytes. Preliminary analytical results indicate that the TMBs and/or TPH concentrations in soil samples 11-WH-W01@5' and 23-WH-E01@5' exceeded the ECMC Table 915-1 Protection of Groundwater Soil Screening Level Concentrations. Additional analytical results are pending laboratory analysis and final reporting. Groundwater was not encountered during wellhead cut and cap activities. Excavation and assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 30264 (approved Form 27 Document No. 403449346). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Soil sample location and field screening data are provided in Table 1. Field notes and a photographic log are provided as Attachment A. The State Notification email is provided as Attachment B.
