Comment: **It was observed in this inspection that the Location does not meet ECMC 1004 reclamation standards. Vegetation observed on Location is predominantly Undesirable and Noxious Plant Species including Bull Thistle (Cirsium vulgare), Houndstongue (Cynoglossum officinale), Common Mullein (Verbascum thapsus). Additionally, the culvert at the Location entrance has not been removed/reclaimed.**
