<p>Following tank battery decommissioning activities at the Morning Fresh/Sarche Production Facility location on June 7, 2024, seven (7) confirmation soil samples were collected from the locations of the former facility infrastructure. The soil samples were submitted for laboratory analysis of the full ECMC Table 915-1 analytical suite, using standard methods appropriate for detecting the target analytes. Based on the preliminary analytical results, a verification soil samples were collected on June 10, 2024, and submitted for laboratory analysis of select Table 915-1 constituents that failed in the initial samples (pH and/or As, Ba, Se). Laboratory analytical results received for the verification soil samples on July 1, 2024, confirmed that the pH values in soil samples SEP1-B01@3", SEP1-B02@3", and SEP2-B01@3" exceeded the ECMC Table 915-1 standards and site-specific background levels. The remaining analytical results for the soil samples collected during facility decommissioning activities were in compliance with ECMC Table 915-1 standards, and/or within site-specific background levels. Groundwater was not encountered during initial facility decommissioning activities. Excavation and site assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 34888 (approved Form 27-Initial Document No. 403731570). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Soil sample location and field screening data are provided in Table 1. Field notes and a photographic log are provided as Attachment A. The State Notification email is provided as Attachment B.</p>
