This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection, the following compliance issues were observed:

- 1) Storm water- Failure to maintain chemical BMP with a CA date of 7/1/2024
- 2) Housekeeping - Wildlife protection for chemical containment needs maintenance with a CA date of 7/5/2024

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
