<p><a href="#">COGCC Inspection Report Summary</a>                      On Monday 7/8/2024 at approximately 11:30 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KMG Jeffers 12-35 location #305743 in Weld County, Colorado. While there, I observed that the battery sign producer decal required replacement, weeds were growing throughout the location, and the battery had sustained heavy erosion damage. During this inspection the following possible compliance issues were observed: Rule 605.e. with a corrective action date of 8/9/2024, Rule 606. with a corrective action date of 8/9/2024, Rule 1002.f.(2)C. with a corrective action date of 8/9/2024. A follow up inspection on this site needs to be conducted to ensure the compliance issues have been corrected to comply with ECMC rules.
