INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Soil samples were collected on 9/9/2022 and 2/8/2023, 3/28/2024, 4/4/2024 and 5/29/2024. Analytical results along with BG samples indicate no organic impacts. 22 soil samples exceed Table 915-1 levels for EC, SAR, pH and/or Boron. Background samples exceed Table 915-1 Arsenic levels; Local Clean-Up Level is 9.625 mg/kg (1.25*7.7 mg/kg). Further excavation and confirmation samples are needed to the determine vertical and lateral extent. Mull Drilling would like to request a reduced analytical suite for EC, SAR, pH and Boron only.
