<p>It was observed in this inspection that Final Reclamation has not been performed in accordance with 1004 Requirements.</p> <p>-There is an area ~24x85 feet on the south end of the Location where gravel has not been removed, area hasn't been decompacted, and where desirable perennial vegetation is not established; area appear to be the former pumpjack location. Additionally there is a pile of rock material that remains stored at the well area. Gravel/rock material requires removal and areas reclaimed.</p> <p>-There is an area ~24x16 on the southeast, as well as areas on the northeast end of the Location where desirable perennial vegetation has not established, or is progressing towards 1004 standards. .</p> <p>Additionally, noxious weed establishment was observed throughout the Location; including Canada thistle, Houndstongue, Bulbous bluegrass. Ongoing weed management is not occurring.</p>	trujilloam	07/02/2024
