<p>Pursuant to Form 6(s) 403433754, well was P&amp;Ad 6/19/2023.</p> <p>Pursuant to Rule 1004.a, all debris, abandoned gathering line risers and flowline risers, and surface equipment shall be removed within three (3) months of plugging a well.</p> <p>It was observed in this inspection that anchor equipment remains on the east end of the Location; pipe risers observed at surface on the north end of the Location; equipment requires removal.</p> <p>Noxious weeds (Hounds tongue) observed, though weed management efforts are evident; ongoing weed management required until location receives a passing final reclamation inspection.</p> <p>Final reclamation of the Location remains outstanding; remediation proj. 30484 for facility closure currently "in process". Quarterly updates for the project are being submitted and work to resolve the remediation appears to be ongoing. Final Reclamation including, but not limited to, compaction alleviation, recontouring/regrading, replacement of topsoil and reclamation of the Location and access road will be required upon Facility Closure.</p>	trujilloam	07/02/2024
