At approximately 9:00pm (4/15/23), lease operator on location identified a spill on the Knight #9 well (photo attached to Form 27 #403710935). Within 5 minutes the Knight #9 well was shut in. Clean up to begin shortly. ***Correction, leak is associated with the Knight #12 wellhead line (remediation will continue to be reported under Knight #9 for consistency). Source removal included 8'x12' excavation to a depth of 2 feet bgs (excavation extent presented on Figure 2). Further excavation is needed to address impacted soil identified in the vicinity of SS-1, SS-2, SS-3, SS-4, and SS-6. The excavation extent and soil sampling analytical results will be documented in the next Form 27 submittal.
