Remaining riser and weed issues observed in previous inspections have been resolved.</p> <p>Signage (posted at the Location's entrance) as well as the Location's perimeter fence remain, and will require removal to receive final passing; fence has not been maintained and is in disrepair along sections.</p> <p>Upon removal of the sign and perimeter fence, submit a new Form 4 "Final Reclamation Complete" notice with photo documentation of removal.</p>
