Please refer to inspection 708900877 conducted on 06/26/2023 &amp; inspection 708903328 conducted on 03/13/2024, previous corrective actions have not been completed.

Location is within High Priority/Density/Black Bear Habitat areas.

Location is in close proximity to Rule 411a Surface Water External Buffer.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Housekeeping - Unused equipment on location with a CA date of 07/28/2023
2. Housekeeping - Cellar cover not properly installed/wildlife & personnel hazard & wildlife egress not properly installed with a CA date of 03/28/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
